Puppy is sold as a pet. Puppy is healthy to the best of our knowledge at the time of pick up. Puppy has been dewormed, vaccinated as is age appropriate, and has been microchipped. We will provide a health record with all the information for you.
Price & Payments

The Purchase Price of the Puppy is \$\_\_\_\_\_. A deposit of \$500 will secure your spot on the waitlist for a puppy and will lock in your price for 24 months from the date of deposit. The remaining \$\_\_\_\_\_ is due the first Friday after the puppy turns 9 weeks of age or at pick up, whichever comes first. If 24 months passes and a puppy is not selected, the buyer will be subject to the current price and the deposit will be applied to the current deposit price. In the event the buyer wants to cancel their spot on the waitlist, 50% of the deposit amount is refundable. The other 50% is nonrefundable because it covers the service of managing the waitlist. Payments are accepted through Venmo @annawilkens, Zelle (402-419-4299), cash, and checks (checks only accepted for deposits, not final payment)

#### **Health Guarantee**

We do our very best to select healthy breeding stock, pair them complementarity, and raise healthy puppies. In the event that your puppy has a genetic health defect that could have been prevented with better breeding, we will take responsibility for that defect. The conditions for the guarantee are as follows:

- All diagnostic paperwork must be presented to us, so we can do a full assessment with our veterinarian.
- The defect must be identified within 2 years of purchase.
- In the event there is a defect in the dog, and the above conditions have been met, we will either replace the dog or refund the purchase price.
- We do not require the dog to be returned to the seller, to receive a refund.
- Refund over 50% of purchase price or replacement of dog will be at the discretion of seller

This contract does not cover the following: viral illnesses, parasites, infections, giardia or coccidiosis or kennel cough. It also does not cover illnesses due to the ingestion of foreign objects, food, chemicals, stress related issues, behavioral issues, physical injuries and/or illnesses which may have occurred and/or contracted during transport to the buyer.

#### Rehoming agreement

Life sometimes happens, and we are still on your team if you can no longer care for your dog. In the event you find you can no longer care for your dog, they can always be returned to Wildcat Hills Doodles. We will accept any of our dogs back at any age, in any condition, no questions asked about your situation. We will ask about the health and temperament of the dog, so we can do right by the dog once returned to us. If we receive a returned dog, we will do whatever is best for the dog, whether that means retiring the dog with us or finding them a new home. Buyer will give up all rights to the dog. No money will be returned for the dog.

## **Contacting Us**

We agree to be available to the best of our ability whenever you have any questions or concerns during the life of your dog and beyond. Due to the lifestyle of breeding dogs, we aren't always able to pick up the phone, but please text message, especially if it is urgent (ie. you are at the Vet Office and need quick information), we can usually respond quickly. In the event that it is urgent, please begin your text message with "URGENT" or "911." Much the same, we appreciate you giving us a few hours to respond to less urgent inquiries, so that we can provide the proper response and information. If you do not get a response within 24 hours, please message again or call, it is no bother. Text Message to **402-419-4299** is the fastest avenue to get a response. We do not require you to contact us if you do not want to (the exception being health issues regarding your health guarantee, please see below). ## Spay/neuter agreement

Buyer agrees that this dog shall be spayed/neutered by (equivalent to 6 months of age).

In the event a solution cannot be reached between the buyer and breeder, a mutually agreed upon, informed, neutral third party can be brought in to help find a solution, such a Veterinarian Specialist
